**PRESENTATION AND INVITATION FOR PARTICIPATION IN THE REORGANIZATION OF THE

Hidrogradnja is a construction company which was founded on 17.02.1947. Since its establishment, it has undergone a series of status changes.

During several decades of business, Hidrogradnja has been engaged in the construction of hydrotechnical projects(hydro and thermal power plants, tunnels, (reservoirs)tanks, water purification plants, water supply systems, sewer systems, regulation of river flows, irrigation systems, etc.), civil engineering works(construction of roads, railways, bridges, tunnels, viaducts and etc.), high-rise building(residential buildings, public and business facilities), projects in industry and mining(industrial halls, plants, power lines, surface mines with accompanying facilities and etc.), design and development of investment technical documentation, production of building joinery, locksmiths and constructions, maintenance and repair services for construction machinery and transport equipment, transport services, commercial services, etc.) and production of building materials (quarries, concrete elements production and concrete products).

Hidrogradnja has built 27 hydroelectric power plants in our country and 7 in the middle east.

Hidrogradnja carried out works in several countries in the world, mainly hydroelectric power plants and water supply.

We are in the process of developing a reorganization plan and looking for a strategic partner.

It is important to point out that Hidrogradnja has healthy assets in attractive locations where it is possible to build business centers and apartments.

In addition, Hidrogradnja has several quarries, quarry Hadžići with dolomite and a stock of 12.000.000 m<sup>3</sup>, quarry Kakanj which has a marble for the production of cement for the raw material, where a 15-year shipment has been contracted. Inventories of quarry are 4.400.000 m<sup>3</sup> and in the end amphibolite located in our quarry Fojnica, where Hidrogradnja owns 42%.
